Reports

ATHLETIC:

Mr. Edmunson reported on the football team making it to state this season. We have received various compliments from spectators and coaches on the opposing team about our coaching staff and players. They represented CHS with respect and good sportsmanship. Basketball is a go and things are getting into swing for the season. Cheer will be put on hold for now, as there will not be crowds allowed at games.

SUPERINTENDENT/CHS:

Mr. Edmunson reported that we will be having some sort of observance for Veteran's Day. It will be different than usual, as we don't want to compromise any vets' health with possible exposure to anything, but we will still honor our veterans and make sure students know what it is all about. We are now back in Stage 3 of COVID, which means no gatherings of 50 or more. This means our horn contest and fall sports banquet will be postponed for now. Basketball games will be home team parents and essential people only. All games will be streamed live for the rest of the fans to watch. At this point we have had 3 part-time staff members, 2 elementary students and 6 high school students test positive for COVID and each of them were quarantined, along with those they have been in extended direct contact with immediately. They have continued with remote learning to keep on track and all of this has gone quite smoothly. We have had some issues finding enough substitutes to cover where needed, but the staff has really stepped up to help where they can. Mrs. Pfeifer has started to offer a grab-and-go option for all students that will consist of a cold sandwich, veggies, fruit, chips/crackers and milk. This seems to be a popular option for those that want to grab their meal and take it to the high school to eat.

CES:

Mrs. Grooms reported that October was a very busy month around CES. Staff has had some adjustments due to COVID-related absences, but all have adjusted well and are on track making recorded lessons for any students needing distance learning for now.
